【AXA 安盛馬到功「盛」大抽獎】條款及細則 (「條款及細則」):

活動期限

1. **【AXA 安盛馬到功「盛」大抽獎】** (「抽獎活動」或「此推廣」) 由安盛金融有限公司 (「AXA 安盛」) 主辦。抽獎活動推廣期為 2026 年 2 月 1 日 00:00 至 2026 年 3 月 31 日 23:59 止 (「推廣期」)。此推廣受下列條款及細則約束。
2. 所有與此推廣相關之時間及日期根據香港時間及以 AXA 安盛伺服器紀錄為準。如於推廣期以外參加或登記此推廣，均視為無效。

合資格人士及抽獎規則

2. All times and dates related to the Promotion are Hong Kong Time and subject to the record of AXA's server. Participation of the Promotion and/or registering for the Lucky Draw outside the Promotion Period will be deemed invalid.

Eligibility and Rules of the Lucky Draw

3. The Lucky Draw is exclusive to "AXA customers" (as defined below) who fulfil the following requirements ("Eligible Participants"):
 - (i) be aged 18 or above and physically in Hong Kong at the time of registering for the Lucky Draw;
 - (ii) hold a valid Hong Kong Identity Card or travel document ("Valid Identification"); and

4. “AXA customers” do not include the policyholders or applicants whose policies are distributed by banks.
5. AXA’s records regarding Eligible Participants and/or AXA customers shall be final and conclusive. If a person’s policy of AXA Life, Health & Critical Illness Protection, Savings and Investment plan is not issued by AXA or is subsequently cancelled during the cool-off period, AXA reserves its absolute right to disqualify such person from participating in the Lucky Draw.
6. Duplicated registrations will be deemed invalid; save that only the latest registration will be recorded by AXA without further notice.
7. AXA is not responsible for verifying any personal information provided by Eligible Participants. Registrations containing incorrect, untrue, incomplete or invalid personal information will be automatically void, the relevant person will be disqualified from participating in the Lucky Draw without further notice.

12. Eligible Participants/Winners are responsible for ensuring their personal information (including contact details) they provided upon the Lucky Draw registration is correct, accurate and valid. AXA will not be held responsible for failure in delivering the Winner Notification or Prize collection arising from any personal information provided; in which case, AXA may in its sole and absolute discretion disqualify such person from participating in this Lucky Draw and/or receiving the Prize (if any) and such person is deemed to have voluntarily withdrawn from participating in this Lucky Draw and/or forfeited the Prize (if any).

Unless otherwise specified in these Terms and Conditions, AXA will take all reasonable and practicable measures to keep the personal data collected confidential and ensure that its processing complies with the relevant provisions of the Personal Data (Privacy) Ordinance (Cap. 486). General
